# **Time Commitment & Expectations**

Serving as a Trustee typically requires a time commitment of at least 6 - 12 hours per month, the following provides an outline we have as a Board.

- Quarterly formal Board Meeting held face to face at the VANS office.
- 3 to 4 seminars themed for specific areas of need or training these can often be most appropriately held on line.
- 2 half days as strategic thinking time, with the outcome of continuing to refresh the approach to business and strategy.
- AGM annually in September.
- Task and Finish groups, on specific work areas as part of the VANS Business Plan.
